New Member Application Process

1. Returning the following items in their entirety will constitute a complete Application:
 - Statement of Responsibility of Sponsor, signed and dated by the Sponsor.
 - Sponsor Questionnaire, completed, signed and dated by the Sponsor.
 - Letters of Endorsement (1 from Sponsor and 3 from Endorsers).
 - Confidential Applicant Profile completed, signed and dated by the Applicant.
 - Applicant must attach a photograph of himself/herself and spouse, if applicable, to the application upon submission.
 - A deposit check payable to The Country Club in the amount of \$5,000.00 for an Equity Membership Application, or, \$1,000.00 for a Social or Junior Membership Application.
2. All Applications must be turned in by the 20th of the month to be considered by the Board at that month's meeting.
3. The Applicant then will be invited with his/her spouse, to the next board meeting to be introduced to the Board by the Sponsor.
4. Upon Board approval, Applicant will be posted for 30 days, and thereafter will be voted on by the Board for Membership approval.
5. The Applicant and the Sponsor will be notified of the Board's decision.

All Memberships are purchased and sold through the Club. Social and Junior Memberships are not transferable. The prices for Social and Junior Memberships are determined by the Club. Equity Memberships are sold in ascending order from lowest price on the then current list of Equity Memberships for sale. Each selling equity Member determines the price for which they will sell their Membership. Unless otherwise determined by the Board, the price paid for an Equity Membership by all approved Applicants in any month will be the average sales price of all sold Memberships equal to the number of buyers for that month. The selling Members may change their listed selling price up until noon on the day of the board meeting. An exact purchase price cannot be determined until the Applicant is approved and offered Membership in the Club. To obtain general pricing information please contact the General Manager.

After the Board of Directors has met the Applicant and after the 30 day posting, the Applicant and its Sponsor will be notified of the Board's decision. Any newly elected Members shall be entitled to the privileges and facilities of the Club from the date payment in full is received for Membership. Dues shall be payable beginning the first day of the month, following Membership approval.

All information contained in this Application and the accompanying letter from the Sponsor, and Endorsers, is confidential; however, the Club shall have no liability, despite its characterization of information as confidential, if the Club is required to disclose the information by a court order or other legal authority. The Sponsor Questionnaire, as well as the Sponsor Statement of Responsibility and this Confidential Applicant Profile, must be completed in every detail and mailed/delivered to the Manager of The Country Club, along with the deposit of \$5,000 if applying for Equity Membership or \$1,000 if applying for Social or Junior Membership. The Applicant must attach a photograph of himself/herself and spouse, if applicable, to the application upon submission. The Applicant understands that all information regarding these matters will be made available to the Club's Board and Membership Committee.

The undersigned Applicant is being proposed for Membership in The Country Club. In the event an invitation to Membership is extended by The County Club and accepted by the Applicant, the \$5,000 or \$1,000 deposit (whichever is applicable) will be credited, without interest, against the

Membership purchase price. The deposit is refundable if the Application is not approved and Membership is not granted.

The payment of a deposit **DOES NOT** create or give rise to any right whatsoever to Membership in The Country Club or require The Country Club to act according to any specific procedure in processing this Application for Membership, nor does it limit The Country Club from accepting such Application or declining an invitation to Membership in its sole and absolute discretion in accordance with such procedures as The Country Club, in its sole and absolute discretion, deems appropriate.

The Applicant understands that Membership in The Country Club is a privilege and grants to a Member the right to use the Club's facilities as determined by the type of Membership (golf course, health facilities, dining facilities, swimming pool, practice areas, etc.). If accepted for Membership by The Country Club, the Applicant acknowledges, on his or her behalf and his or her immediate family's behalf, the existence of all risks attendant to use of the Club's facilities. Applicant, on behalf of himself/herself and on behalf of his/her immediate family agrees that neither The Country Club, its directors, officers, employees nor agents shall be held liable for any injury or death resulting from the use of the Club's facilities, whether due to their negligence or otherwise.

Applicant authorizes the disclosure and release of information to the Club or its Agent(s) for the purpose of investigating the Applicant's character, general reputation, personal characteristics, and mode of living, reputation and financial condition. The Applicant hereby consents to such investigation and to all such disclosures and agrees never to make any demand upon the Club or any other person (including, but not limited to, any informant) for the disclosure to Applicant or any other person or entity of said information. The Club intends to treat all such information as confidential.

The Applicant hereby releases and discharges The Country Club, its directors, officers, Members and every person who furnishes, transmits or processes such information for the purpose herein mentioned, from any and all liability for having done so, and this release shall be binding upon Applicant, Applicant's spouse, Applicant's children and other immediate family members, personal representatives and heirs.

If elected to Membership, the Applicant agrees to abide by all By-Laws, rules, regulations, and policies of The Country Club as set forth by the Membership and the Board of Directors as they may exist from time to time.

I certify that, to the best of my knowledge, the information contained in this Application is complete and accurate. I understand that any misrepresentation shall be cause for denial of further consideration, and that my Membership may be terminated if a misrepresentation is later found to have been made.

I hereby acknowledge that my account with The Country Club shall be considered delinquent if not paid in full within thirty (30) days after the date of the monthly statement and will be subject to the lesser of (i) a one and one half percent (1.5%) charge per month, or (ii) the maximum amount that may be contracted for taken, reserved, charged or received under law. This late charge shall accrue thirty (30) days from the date of the monthly statement until the account is paid in full. I acknowledge that The Country Club may take whatever action it deems necessary to effect collection, including, without limitation, suspension or termination of my Membership or legal action, including the involuntary sale of the Membership to pay any past due amounts. I acknowledge that I shall be liable for all costs and for any expenses of such legal action and reasonable attorneys' fees, including any fees required in connection with appellate proceedings.
